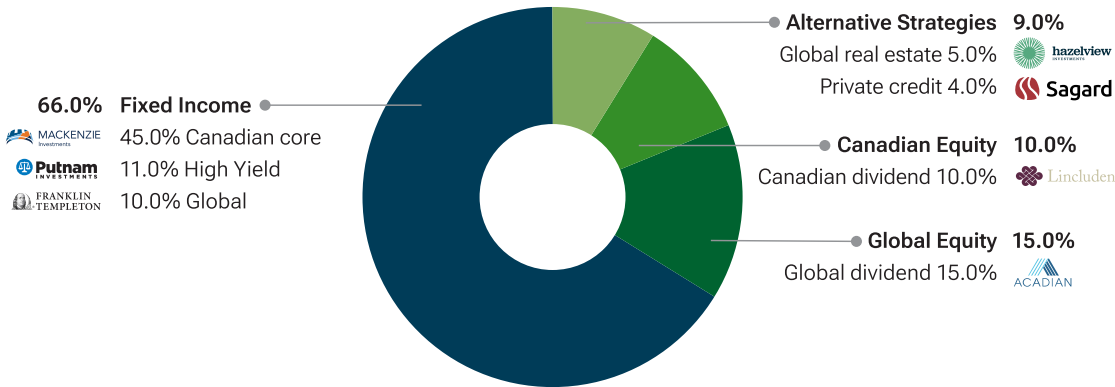

Neutral portfolio allocation¹



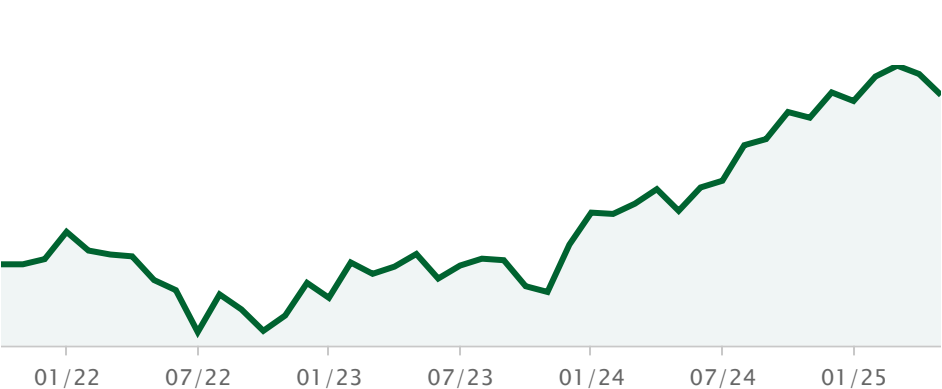

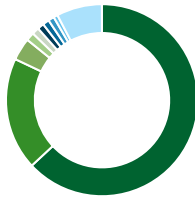
